Administration

December Lockdown- Mr. Spencer explained the reason for the Dec. lockdown and the procedures that were followed. It went like clockwork as far as what the teachers and students knew to do, the connected messages that were sent, etc. Mrs. Hill commented that she was in the building as the lockdown occurred and said it went very smoothly. Mrs. Catapano asked if there would be a plan in place from the police department for the protection of the people in the car rider line. Mr. Spencer shared that in this case though the police were looking in our neighborhoods and bus stops to ensure the safety of the students before getting off of the bus. There was not a sign of danger in the direct school area. Nobody had entered the building. Mr. Spencer could not release students from the lockdown until the official word from the police department. The members commented again that they felt their children were in a safe place and they were pleased with the procedures and communications provided.

Car Rider Number Cards- We discussed a proposal to go from the car rider cards being lunch numbers to names. Currently our parents who pick up their children from the car line show a card with their lunch number on it. Mrs. Hasty our TA who is the "caller" for car line reads the number and then tells the student which letter A-F to stand. Calling out a child's name would be faster. It was also suggested to change the letters A-F to numbers 1-6. Representatives will meet with their grade levels to get feedback. We will discuss a decision on this agenda item at the next meeting in March.

School Letter Grades- Mr. Spencer shared that on Feb. 5th the data for letter grades A-F will be released for NC Schools. The state no longer recognizes schools with the terms School of Excellence, or School of Distinction. Schools will be either an A, B, C, D, or F school. It will be a 15-point scale. The grade will be determined by 2013-2014 End of Grade testing data.

Our school's overall reading percent on grade level was 73% and math was 87%. Based on that data we have put many programs in place.

- Tutors for small group and individual instruction
- Teacher assistants for instruction.
- SHAPE tutoring for students in our After School program.
- BREAK- a mini intersession we have done for selected students for 4 years
- BLAST- School-wide after school tutoring by all Shiloh teachers on designated Tuesdays for selected students
- Appropriate and relevant staff development each month
- small group differentiation
- Interventions for struggling students
- Literacy Night
- Show Me/Book swap
- Winter Marshmallow Challenge (To encourage reading at home)
- Article on WIN time from our third grade teachers
- Using data to drive instruction

Mr. Spencer shared that the letter grade will be a snapshot of what the school is doing. We are still a school to be proud of with both state and national recognition.
