Statement of Purpose:

At Benton Heights Elementary, we believe that parent participation is an integral part of the education of the students in our Title I Program. They are our partners in teaching and nurturing. Procedures for Parental Engagement:

Student Progress

- Providing progress notes on mid-term, and report cards each 9-week term
- Timely parent / teacher conferences as required and/or needed throughout the year
- Internet access to student grades and assignments via Home Base
- We strongly encourage parent / teacher conferences for every student at the end of the first grading period.

Curriculum Information

- Informing each child's parents of curricular expectations by sending UCPS pamphlets
- Inviting parents to learn more about classroom content and expectations during curriculum nights scheduled throughout the year
- Providing materials and suggestions to parents to help them promote the education of their children at home

Communication with the Home

- Providing timely responses to parents' questions
- Utilizing students' agendas and communication folders to communicate homework and student / parent / teacher concerns, praise and other information
- Employing a parent / student / teacher / school liaison to help make communicating across prominent languages more productive
- Consulting with parents about how the school can work with parents to achieve the program's objectives through "Boost Our Tigers" (our parent involvement organization)
- Providing a Student Handbook to help parents and students know the school's expectations in all areas
- Weekly Connect Ed messages from the principal to inform about current school events
- Utilization of social media (Twitter, Facebook)
- Consistent updates to BHESA website
- Monthly grade level newsletters to home

Community Interaction

- Encouraging participation of parents in school activities
- Notifying all parents in the Union County Public Schools' District of the Annual Parent Engagement (Public Hearing) Meeting
- A variety of business partnerships (arts, churches, charities, and special events)
