College Board Update

<u>SAT</u>

-College Board has suspended ALL testing until at least June 6. These facts are changing rapidly, and at this point, this is the soonest test date that students may register for at this time. Students can register at www.collegeboard.org to secure a testing placement. College Board is working with state and local schools to approve additional testing sites to accommodate the high volume of testers in June.

-As previously communicated, WHS was assigned to administer the SAT test on March 25. At this time, a makeup date has not been set.

-Students who were registered for a Saturday SAT test in March or April will be receiving refunds over the next few days.

<u>ACT</u>

-All juniors completed the ACT test on February 25. If a student was absent, he/she was scheduled for makeup testing on March 17. We have not been provided a makeup testing date for the school-based ACT. If a student registers for the ACT test on his/her own, he/she will be prompted for an ACT account ID code. At this time we do not have this have this information as tests are still in process of being scored. ACT has advised testers to create a NEW account in order to register for future testing. Once we receive ACT account ID's on our score roster report, each student will be provided a copy and will need to contact ACT customer support to order an account merger of the two different accounts so that one's test scores will be aligned in one account. Typically, we do not receive this information until June, and score reports will NOT have the account ID.

-ACT has suspended the April 4 test date until June 13. Please know that ACT will offer test dates on June 13 and July 18 of 2020. If you were registered for the Saturday, April 4 test date, ACT will NOT automatically register you for the June 13 test date. You will receive an email with instructions that you will need to follow in order to register. You can register for June and July test dates at <u>www.act.org</u>

AP Testing

-College Board is committed to providing students with the opportunity to receive college credit and honor the work students have committed to by participating in AP courses. At this time, they are still in the process of identifying strategies to help facilitate testing.

We realize that a lot of this information is overwhelming with so many unanswered questions. Please know that colleges are aware of the struggles that College Board and ACT are facing with offering testing to so many students.
