

What to Expect (For Students)

This document is to support your understanding of how this school year will look. As always feel free to ask questions or seek guidance if you like.

Plan B

- These students opted to attend school once a week and the other 4 days in a virtual format. If school resumes they will be required to return.
- If attending in person on a given day students will arrive at school and prior to exiting their way of transportation they will be screened for Covid and their temperature taken. If cleared they will exit and travel straight to their first block class. **Face masks are required!**
- Students will still have lunch in the cafeteria but with social distancing strictly enforced. Those who purchase lunch in the cafeteria will only be able to buy a prepackaged lunch. Outside food will **NOT** be allowed in the building this year. Those who wish not to purchase MUST have their lunch with them upon arrival for the day.
- Students are expected to participate in their classes just as if they were attending school each day.
- Students will be held accountable for their attendance. Teachers will determine the sign in time for their classes.
 - Example: start of class, a specific time (perhaps you want to work with students who are face to face first) etc
 - Any student NOT signed on at that given time will be marked absent. This absence will be no different than it has been in the past. More than 7 absences leads to an automatic class failure unless time is made up.
 - Students may provide a doctor's note or other type of note to provide an excuse for this absence. It will need to be emailed to Ms. Bowen glenna.bowen@ucps.k12.nc.us for the absence to be changed to excused.
- Teachers will provide live instruction for ALL students in a virtual format. These live lessons will be approximately 30 minutes in length. This will most likely vary class to class.
- The remaining time students will work on activities that are built in through Canvas.
- Fridays are virtual days for all students. Students will have the opportunity to take assessments, do class work, ask questions of the teachers, etc. Students will attend each block at the regular scheduled time.
- Parents will NOT be allowed to drop items off for students. Forgotten items at home will need to remain at home. Medicine and eyeglasses will be permitted.
- Parents may not come in to sign out students. Please phone the front office at 704-296-6319 to have your student released. We have cameras to view you at the door and will release them at that time.

Plan D

- These students opted NOT to attend school at all. This means all of their classes are virtual. If the counselors were able to enroll them into a virtual class that was offered by UCPS or by NCVirtual, it was done. If the course was not offered or unavailable, the virtual student may appear on your class roster.
- Students who participate in the virtual format will not be required to sign in to live instruction. Their attendance will be captured by their Canvas log in and completion of assignments. They will complete the same work as Plan B students.
- Students will be able to work and view lessons at their own pace. These students will still be required to meet classroom assignment deadlines. It is recommended that for Plan D and Plan B that assignments are given a weekly due date instead of daily.

Returning at End of Day

- Any student who returns at the end of the day for a scheduled activity will need to go through Covid screening. Information on the location for that to occur will be provided from those holding the event.
