Mr. Miller will present this on September 9, 2009. We would like to have a presentable draft completed by Tuesday.

Deb Cochran asks about measurability of outcomes.

Dr. Jones replies by saying that we indeed need to think about the measurability and use that to place the time frame of two years. We can also give ideas of how to measure progress and outcomes.
