## Approve Minutes from September: Actionable

• It was moved for the minutes from the September 2013 SBMT meeting to be approved. The motion was passed unanimously.

## • Budget Information: Actionable

- Final budget numbers are in and Dr. Plue presented a proposed budget for the 2013-2014 school year. This budget takes in to consideration the 20% decrease in instructional funds due to changes with how the district will be dealing with computer replacement. A motion was made by Michael Hastings to approve the budget. The motion was seconded Larue Marone and voted for unanimously by present members.
- Changes made to the budget when compared to the 2012-2013 school year's budget include the following:
  - Technology line item reduced from \$25,000 to \$10,000. This amount is meant to support replacement of
    peripheral technology items such as projectors, smart boards, etc.
  - Copier line item reduced from \$30,000 to \$25,000. With students having access to the 1:1 machines and Google Drives, copier usage is expected to decrease.
  - Staff development line item reduced from \$14,000 to \$12,000.
  - Reserve money has increased slightly from \$2,770 to \$3,588
- All other areas will remain the same.

## • Dress Code: Gather Input

- Jamaria Sanders, representing Student Council, presented to the SBMT concerning girls wearing high heel shoes.
   She proposed for a 2.5 inch limit on all heels including wedges. Some agree that this does pose a safety concern for students while other think that this may not be that much of an issue. Members of the SBMT were asked to gather input from their constituent groups and report back at November meeting.
