• Approve Minutes from August: Actionable

Budget: Information

- Due to changes in the ADM numbers, there is an increase of approximately \$10,000 in the budget
 - Suggestion of areas to add allotments
 - Science department due to the need to purchase more expensive equipment
 - Staff development
 - o Extra employment to include attendance recovery, tutoring, and summer help
- Members were asked to go back to constituents to discuss ideas for ways to spend extra money and share the budget with departments/constituent groups.

• Driver's Ed: Need Input

- The state legislature is not going to subsidize driver's education during the next year. Schools will still be required to provide a driver's education program to students. Currently students/parents are paying \$55 (\$65 beginning in January) for a course that costs approximately \$350 to teach per student. The school system cannot charge any more than the \$55 (\$65 in January). Up to this point the state has been subsidizing this cost, but with that no longer being an option there is an approximate &750,000 hole in the upcoming UCPS budget.
- Options to combat this hole in the budget include some of the following ideas.
 - Providing the classroom portion of the course online through UC Virtual. This would reduce personnel costs. Parents are concerned that this would adversely affect student achievement of proper driving skills as students learn from classroom discussion only brought on in the seated classroom setting. Concerns also exist of accountability. Are the students actually the ones taking the tests? It is the general consensus of the group, especially the parents, is that seated class time is necessary. Some feel that the class time now is not enough; therefore, cutting back would be even worse for the students.
 - Teach fewer classes. Parents are concerned of the availability of class slots.
 - It was suggested that if online classes became a reality, students should be required to come in to a testing site (with appropriate school identification) to prove that they are actually taking the appropriate tests themselves.
 - Charging parents the actual costs of driver's education. Concerns were raised as to whether or not parents would be willing to pay market value for this opportunity. Some agreed that it was worth the value while others worried of financial issues. Some were concerned that this idea could lead to more less-skilled drivers in lower socio-economic areas?
 - Questions were raised about the possibility of reducing the number of required days of driver's education.
 A major issue with this idea was of DMV requirements.
