Dr. Plue provided refreshments and expressed appreciation to the team for serving.

Call to Order

Mrs. Perkoski called the meeting to order at 4:00 pm.

Approval of Minutes

The minutes from the April meeting were unanimously approved.

Club Membership (Information)

Dr. Plue introduced Mr. Trent Thomas who has expressed enthusiasm about getting students more involved in clubs. They explained plans to use the I/R period (before I/R actually begins) to show videos featuring different clubs and encouraging students to become involved. The push is to exploit the proven link between student involvement and success in high school. Mr. Thomas will coordinate the efforts to increase student involvement in clubs.

Item 5: Field Trip Qualifications

After a suggestion at the April meeting from Mr. Tyson that we tie a student's field trip attendance to the student incentive program (i.e. students not be eligible to attend field trips unless they scored at least 4 pts. in the most recent student incentive period), the team was asked to gather information from their groups on this to bring back to this meeting. After some discussion regarding exceptions for students who are part of a competing team, for example, it was moved that students who do not have at least 4 points in the latest student incentive ratings not be allowed to attend field trips. This passed unanimously.

New Membership

Each representative on the SBMT serves a three-year term, according to the team guidelines, before rotating off. Some members will be rotating off, and have been asked to take care of the election of their replacements from their constituent groups before the end of the school year for the beginning of school meeting. Those areas who require new members are: English, Social Studies, CTE, Classified Employees, three parent positions, and students.

School Improvement Plan Update

Dr. Plue shared the new school improvement plan, which addresses the same priorities and strategies. He will email this to the FHHS faculty for their vote after approval and recommendation by the SBMT. It was moved that the school improvement plan be approved and put before the faculty for their vote. This was unanimously approved.

Student Incentive Data

Dr. Plue shared the student incentive data from the fifth six weeks. His charts compared first six-weeks data with the fifth six-weeks. While more students gained all 10 points in the fifth six-weeks, the overall percentages in the points break-down were similar to the first six-weeks. Dr. Plue expressed a desire to see movement to reduce the number in the top of the "triangle," (those students with 0-3 points). He mentioned that using the incentive points to determine field trip eligibility in the future will serve as further incentive. Continued use of the model and the incentives will help make it a norm at FHHS.

Adjournment

The meeting was adjourned at about 5:00 pm.
