- 1st Accidental Incident causing damage is at no cost
- 2<sup>nd</sup> Accidental Incident causing damage is at no cost
- 3<sup>rd</sup> Accidental Incident causing damage will be a cost not to exceed \$25.00
- 4<sup>th</sup> Accidental Incident causing damage will be the cost of the repair
- 5<sup>th</sup> Accidental Incident causing damage will result in possible loss of computer privileges and/or cost of repair
- Fee due by September 30, 2016
- Accounts must be current to be eligible for insurance
- If Technology Fee is not paid Parents/Guardians are responsible for cost of any damages, including accidental.
- · Parents/Guardians are responsible for the cost of lost, stolen, or intentionally damaged devices/repair
