I understand this NFM Townhomes development consists of 86 townhomes on approximately 17 acres located on Old Monroe Rd, near Radiator Rd (tax parcels 07090018 and 07090018B). Currently this development is located within the following school attendance areas:

Shiloh Valley Primary School at 90% rated capacity Shiloh Valley Elementary School at 71% rated capacity Sun Valley Middle at 84% rated capacity Sun Valley High at 89% rated capacity

PLEASE NOTE: Although the above schools are the current assignments for this area, the Union County Public Schools Board of Education has the obligation and reserves the right to modify assignments in order to optimize facility utilization and efficiency.
