1. School Improvement Plan

2. NCSTAR
 - a. A2.04 - Planning Standards Aligned Units (2 year goal)
 - i. Indicators:
 1. Reviewing units prior to teaching: looking at standards that are addressed.
 2. Reviewing end of unit assessments and matching the rigor
 3. Updating grade level calendars to reflect changes in instruction.
 - b. A4.01 - MTSS (3 year goals - we are in year 3)
 - i. Indicators from previous years:
 1. Master schedule with WIN block
 2. Math instruction template
 3. Lesson plans support Tier 1
 4. Small group plans

 6. Interventionists collecting data

 - d. Possible addition: Parent communication (E1.06)---We've done this indicator before but Dr. Daniels said Title I schools may need to add for parent engagement.
